



## CAHR/CPAR Registration & Transfer Fees

Registration fees are based on the membership status of the Recorded Owner of the horse OR on the membership status of the horse's new owner if a transfer takes place. Each ownership account has a membership number. **To qualify for member rates, the name on the membership must be exactly the same as the recorded ownership of the horse.**

Memberships expire each year on Dec. 31.

### LEGAL ENTITIES OF OWNERSHIP

Any forms of multiple ownership must be recorded in either an "AND" or an "OR" format.

**An "AND" form of ownership** is where BOTH / ALL signatures of the recorded owners are required for ALL transactions.

**An "OR" form of ownership** will allow any ONE signature EXCEPT in cases where a Transfer is occurring and the sole signor is the horse's new owner. In this case, all other owner(s) must sign.

The following examples show how ownership could be structured on a horse's registration papers, and **each would be considered a separate ownership account:**

Joe Smith  
Joe Smith AND Jill Smith  
Joe Smith OR Jill Smith  
Joe Smith Arabians Inc.

**NOT PERMITTED:** Joe Smith AND/OR Jill Smith

If the horse is owned by "Joe & Jill Smith", the membership must be for "Joe & Jill Smith" to qualify for member rates. A membership for "Joe Smith" will not qualify for reduced rates pertaining to horses registered to "Joe & Jill Smith".

Farm names, corporations or organizational names will be accepted but an Owner Authorization form must be completed and returned to the CAHR office before the transfer will be completed. This form indicates who is authorized to sign documents on behalf of the owner(s). A form can be obtained from the CAHR office.
